

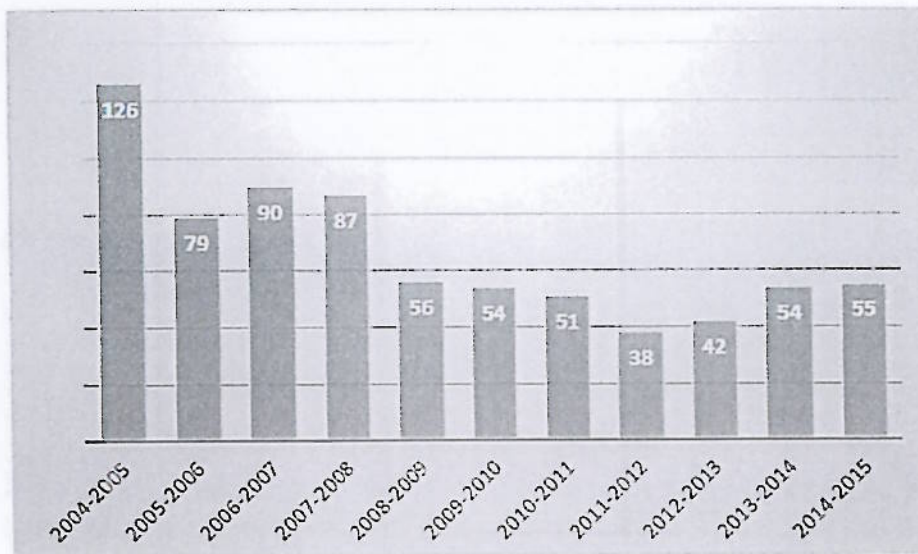

YEAR END REPORT RECOMMENDATIONS FOR EXPULSION

2014 - 2015

Part I: Statistical Information

1. Total number of students recommended for expulsion during the 2014 - 2015 school term is 55. (1 student was reinstated, 4 students were placed on an interim education program by the recommending school, 8 students withdrew voluntarily, 3 students were placed out of District and 39 students were transferred to other schools/sites).

All suspensions of five days (with a recommendation for expulsion) are reported to School Operations Services and resolved by School Operations Services in cooperation with school staff, parents and community agencies as deemed necessary.

Part II: Year-End Follow-Up Information With Respect to Expelled Students

1. Movement out-of-district:

2 students moved out-of-district after placement.

2. Attendance:

Attendance ranged from Unsatisfactory to Excellent. Approximately 49% of the students were in the Satisfactory to Excellent to range.

3. Achievement:

Achievement ranged from passing all courses to not passing all courses. Approximately 57% of the students were passing all or most of their courses.

4. Transition:

A majority of the students (approximately 97%) are remaining in the District, either at the present school, returning to their home school, or another school in the District, or are graduating.

6. Observations – School Operations Services:

The number of expulsions only exceeded last year's level by one. Principals and their staffs continue to work diligently at putting in place numerous interventions for students prior to proceeding with expulsions. Typically School Operations Services and the Assessment Support Intervention and Success Team are involved in finding appropriate interventions and placements for expelled students. Many of the students, particularly high school students, are placed at our Fresh Start sites and many this year at Cardinal Collins Academy Centre. These placements work well especially when expulsions are in the middle of a semester when scheduling becomes an issue.

The School Resource Officer program, the School Team Advisor for Youth program, and the Family School Liaison Worker program are critical to ensuring that expulsions are kept to a minimum.
