Canadians Want Harper to Intervene on Behalf of Brenda Martin

Half are ready to boycott Mexico as a holiday destination; and 61% call for an official travel warning

[VANCOUVER – Mar. 19, 2008] – A large proportion of Canadians want the Prime Minister to become personally involved in the case of Brenda Martin, and half say they would avoid Mexico as a holiday destination, according to the *Toronto Star /* Angus Reid poll.

Martin has spent more than two years in a Mexican jail on money laundering and criminal conspiracy charges. Martin—who has not been convicted, but remains incarcerated before her trial takes place—maintains that she has never confessed to the alleged crimes. Two-in-five Canadians (41%) are following the developments of this story "very" or "moderately" closely.

In the online survey of a representative national sample, 71 per cent of respondents believe Stephen Harper should urge for the release of the Canadian woman on humanitarian grounds, and 61 per cent think an official travel warning for Canadians to avoid Mexico is in order.

In addition, 50 per cent of respondents would boycott Mexico as a holiday destination, and 44 per cent would stop buying Mexican products sold in

From March 17 to March 18, 2008, Angus Reid Strategies conducted an online survey among a randomly selected, representative sample of 1,045 adult Canadians. The margin of error for the total sample is +/- 3.0 %, 19 times out of 20. The results have been statistically weighted according to the most current education, age, gender and region Census data to ensure a sample representative of the entire adult population of Canada. Discrepancies in or between totals are due to rounding.

Canada. Another measure—facilitating Martin with an application for transfer so that, if convicted, she could serve her sentence in Canada—was supported by four-in-five (80%) respondents.

Majorities in both Ontario (54%) and Alberta (51%) are willing to boycott Mexican products, while fewer Quebecers (30%) would actually avoid travelling to Mexico.

In the survey, only 20 per cent of Canadians expressed confidence in the Department of Foreign Affairs and International Trade (DFAIT) coming to their assistance if they were detained in a foreign country. The results are consistent with an Angus Reid Strategies survey conducted in June 2007.

An official document published by the federal government—called "A Guide for Canadians Imprisoned Abroad"—states that Canada cannot actually interfere in the judicial affairs of another country; that if a Canadian breaks the laws of another country, he/she is subject to the judicial system of that country; and that DFAIT can neither protect Canadians from the consequences of their actions, nor override the decisions of local authorities.

The poll shows some misconceptions about what the Government of Canada can actually accomplish in these situations. While 86 per cent of respondents correctly identified that Canadians who break the laws of another country are subject to the judicial system of that country, only 50 per cent know that DFAIT cannot override the decisions of local authorities, and just 47 per cent are aware that Canada cannot interfere in another country's judicial affairs.
