## PETITION FOR REMISSION OF RESTITUTION

NOW INTO COURT, through undersigned counsel, comes the United States of America, who petitions this Honorable Court pursuant to 18 U.S.C. §3573 to enter an order remitting the unpaid portion of the restitution earlier imposed against the defendant herein for the following reasons:

- Judgment was entered by this Honorable Court against the defendant on May 17,
   The judgment included an restitution in the amount of \$37,500.00, of which a \$37,500.00 balance remains.
- 2. Petitioner has been informed by the U.S. Department of Justice, Immigration and Naturalization Service that defendant was deported from the United States to Canada on October 5, 2004.
- 3. 18 U.S.C. §3573 provides that the government may petition the Court to remit all or part of the unpaid portion of a restitution, including interest and penalties, upon a showing that reasonable efforts to collect the restitution are not likely to be effective.
- 4. Petitioner submits that there is no reasonable likelihood that expending further efforts to collect the restitution imposed herein would produce any revenue to the United States. To the contrary, any further efforts at collection would needlessly expend resources that could be

better directed to cases with a greater potential for recovery.

5. Accordingly, the interests of justice mitigate in favor of remission of all of the unpaid portion of the restitution imposed in the captioned proceeding.

WHEREFORE, the United States of America respectfully petitions the Court to enter an order remitting all of the unpaid portion of the restitution imposed upon the defendant in this case.
